## **WHAT EVERY VILLAGE OF LANSING RESIDENT NEEDS TO KNOW** **(Dec 2024)**

Presented here in alphabetical order is useful information for and answers to frequently asked questions by residents of the Village of Lansing.

### **About the Village**

- The Village of Lansing was chartered by New York State in December 1974, making it among the youngest Villages in New York.
- The main reason the Village was formed was to control planning and zoning. The Village uses Zoning Law to manage commercial growth and commercial and residential development.
- The Town of Lansing Water District boundaries were used to form the Village of Lansing boundaries.
- Village residents are also residents of the Town of Lansing and can take advantage of many Town services.
- The population of the Village is around 3,600.

### **Boards and Committees**

- The **Board of Trustees** is our legislative body. It includes the Mayor and four elected Trustees who serve staggered two-year terms.
- The **Planning Board** has five members and one alternate, appointed by the Board of Trustees, who evaluate special permit applications, monitor development, periodically review land use regulations, and make recommendations to the Board of Trustees.
- The **Board of Zoning Appeals** has five members and one alternate appointed by the Board of Trustees. This Board meets as needed to evaluate and rule on variance requests.
- The Village welcomes participation by residents who are willing to become involved in local governance. In addition to the Planning Board and the Board of Zoning Appeals, the Village needs representatives for the following committees and boards:

- Youth Services/Recreation Partnership
- Joint Youth Commission
- Stormwater Coalition
- Water Resource Council
- Recreation Partnership Board
- Climate Smart Communities (CSC)

### **Building/Home Improvements**

If you plan to do any improvements to your home or business, please contact the Building Codes Department to see if you need a permit. Permits are also required for home occupations. **Village of Lansing Code & Zoning Officer Mike Scott-227-3514**

### **Brush Pick Up**

The Village provides brush pick up in the spring and fall. Holiday tree pick up is provided in January. Dates are listed in the newsletter, on SIREN and on the Village website.

### **Community Hall Rental**

The old Village Office conference room has been transformed into a Community Room that is available for Village residents to rent out. The Community Hall Agreement is available on our website under Applications and Forms.

### **Deer Management**

In 2007 the Village established a Deer Management Program in accordance with the laws of the State of New York and directives provided by the NYSDEC to manage the herds of deer within the Village boundaries. In 2015, the Village also began granting additional nuisance permits to control the deer population. Currently, the Village is only using the Nuisance Permit Program for deer management. Please note that this controlled bow hunt is the **only** program that permits hunting within the Village boundaries.

### **Departments**

There are three departments in the Village.

- The **Administration Office** is served by the Clerk/Treasurer, who is appointed every two years by the Mayor. The Clerk/Treasurer is also the Tax Collector.
- The **Code & Zoning Office** is served by the Code, Fire & Zoning Officer and an Electrical Inspector.
- The **Department of Public Works** is served by the Superintendent of Public Works and two Motor Equipment Operators.

### **Dog Licenses**

- The Town of Lansing Clerk's Office issues dog licenses for residents in the Town and Village of Lansing.
- Every resident is required to register their dogs at the Town Office at 29 Auburn Road.
- All dog complaint issues are dealt with by the Town Animal Control Officer.

## **Elections**

- Village Elections take place the 4<sup>th</sup> Tuesday of April each year.
- Every year, the Village elects two Trustees.
- Every two years, the Village elects the Mayor.
- The polling place for Village elections is the Village of Lansing Community Room.
- Village Residents are also residents of the Town of Lansing and can participate in the election of Town Representatives.
- Locations for all other General and Primary elections are determined by the Tompkins County Board of Elections. Your polling place for these elections depends on your residence address.

## **Fire & Police Protection**

- Fire Protection is provided by the Lansing Volunteer Fire Department. There are four fire stations, one is located in the Village on Oakcrest Road
- The Village of Lansing does not have a police department. Police Protection is provided by New York State Police and the Tompkins County Sheriff's Department.

## **Flood Insurance**

The National Flood Insurance Program (NFIP) is available to local property owners and may be purchased from any insurance agent or broker licensed that does business in the State where the insurable property is located. There are only a few properties in the Village which are located in the flood plain.

## **Garbage Collection and Recycling**

- Each resident is responsible for contracting with an independent trash collector for garbage removal. The contractors will explain the tag system and where to get them. Residents also have the option of taking their own trash to the Tompkins County Solid Waste Center (TCSWC).
- Tompkins County provides curbside recycling pick-up every other Wednesday. Recycling must be out at the curb by 6am on your scheduled day.
- TCSWC also hosts household hazard waste drop off events six times a year.
- The Village of Lansing is a Food Scrap Recycling Drop Spot. Residents may bring food scraps to the Lansing Village Office on Saturdays from 10am-1pm.

## **Meetings**

- The Board of Trustees meets at 7:30 pm on the 1<sup>st</sup> and 3<sup>rd</sup> Monday of the month and at 12:00 noon on the second Thursday after the first Monday meeting.
- The Planning Board meets at 7:00 pm on the 2<sup>nd</sup> Monday and the last Tuesday of the month.
- The Board of Zoning Appeals meets as needed on the 3<sup>rd</sup> Tuesday of the month.

- The Board of Trustees holds the Annual Organizational meeting the first May meeting following Village elections. The official year of a Village begins at noon on the first Monday of the month following the village elections. Some of the matters addressed during this meeting are welcoming of elected officials, appointments, setting dates for meetings, designating official newspaper, rules of procedure, authorize training and conference attendance, review of certain policies, and advanced approval of claims.
- All meetings are open to the public, in accordance with New York State's Open Meetings Law.
- Official minutes of all Village of Lansing meetings are posted on our webpage.
- Recordings of the meetings are on the Village of Lansing YouTube channel.

### **Newsletter**

- The Village publishes an electronic newsletter twice a year, in March and October, it can be found on the Village website.
- If you would prefer to receive a hard copy of the newsletter, please contact the Clerk/Treasurer, Jodi Dake, at 257-0424, and ask to be added to the newsletter mailing list.

### **Parks**

- Dankert Park is located on Uptown Road. The park consists of a playing field, pavilion and playground. Use of the facilities is on a first-come, first-served basis.
- Marian Hartill Park is located on Northwood Road. The park was built in 2018 and consists of a pavilion, two age-appropriate playgrounds, basketball court, an all-purpose playing field and trails. Use of the facilities is on a first-come, first-served basis.
- Ned Hickey Park is located at the intersection of Craft Road and Leif's Way. It has a pavilion, basketball court and trails.
- Myers Park is located in the Town of Lansing. As a Village/Town resident, you are given free access to Myers Park on Cayuga Lake. Residents can go to the Town of Lansing Recreation Department to get a free access pass for their car. The park consists of a marina, camping, swimming area, pavilions, and playground. Pavilion rentals must be arranged through the Town Recreation Department at <http://www.lansingrec.com/pavilion-rental>. Kayak rentals are available on site.

### **Payment Drop Box**

Village Taxes and water/sewer payments can be left in the secure drop box in the lobby of the Village Hall at 2405 N. Triphammer Road.

### **Recreation Programs**

- The Village contributes to the Recreation Partnership and the Joint Youth Commission. Our contributions and participation enable children who attend Ithaca schools to participate in activities with their school friends.
- Village residents are eligible to participate in all the excellent programs sponsored by the Town of Lansing Recreation Department. Information is available on the Town of Lansing website.

## **Sewer**

The Village of Lansing sewage is processed at the Village of Cayuga Heights (VCH) Sewer Plant. However, the Village of Lansing maintains all sewer infrastructure located within its boundaries. A portion of your water/sewer payments is sent directly to VCH for processing services; a smaller portion is used for maintenance of sewer infrastructure in the Village of Lansing.

## **Safety & Incident Real-Time Emergency Notifications (SIREN)**

Tompkins County SIREN is the official mass notification system used by Tompkins County, the City of Ithaca, and local towns and villages to communicate with community residents during emergencies. Sign up now to receive alerts from SIREN via text message, email, and/or voice message. There are notification lists covering the Village of Lansing, in addition to any other lists from which you might like to receive notifications. Sign up at <https://www.tompkinscountyny.gov/siren>:

- Add your address to receive geo-targeted alerts
- Indicate what types of alerts you want to receive.
- Indicate how you want to be notified by text, email, and/or voice message.

*PLEASE NOTE:* You may sign up at the link above or you can text SIREN to 67283 on your mobile device.

In addition to emergency alerts, you can also choose to receive additional community notifications based on your interests or location. These include notifications about severe weather, safety, health, utility disruptions, major traffic incidents, construction, and more. This service is provided by the Tompkins County Department of Emergency Response at no direct cost to the public

### **If you do not have a computer, you can:**

- Text SIREN to 67283 from a mobile phone
- Visit your local library to sign up online for SIREN on an accessible computer.
- Call 2-1-1 (1-877-211-8667) and someone in our local help line will assist you.

## **Shopping**

- There are three malls located at or near the intersection of Route 13 and N. Triphammer Road.
- A fourth shopping center at the intersection includes a large Tops grocery store. Groceries are also available at Aldi's, BJ's shopping club, behind the Shops at Ithaca Mall, and at the Target Store in the mall.
- There is a Kinney Drug Store in the Triphammer Marketplace. Prescription drug services are also available at the Tops Market and Target.

## **Taxes**

- The Tompkins County Department of Assessment determines the assessed value for all property in the county. It also prepares all tax bills.
- Village tax bills are sent out June 1<sup>st</sup> and are due by July 1<sup>st</sup>. Payments should be made to the Village Tax Collector at 2405 N Triphammer Rd. Payments may be mailed or made in person at the Village Office on Monday-Thursday between 9am and 1pm. At all other times, payments may be deposited in the secure drop box located in the office lobby.
- Village residents must also pay Town of Lansing/Tompkins County taxes in January.

- A majority of the Village is in the Ithaca School District but some of the Village is in the Lansing Central School District. School taxes are due in September or October depending on your school district.

### **Tree Planting Program**

The Village has a Street Tree Planting Program to encourage residents and property owners to plant shade trees along our streets. The program allows reimbursement up to a maximum of \$100 per tree. Shrubs will also be considered under special circumstances where there is a potential interference with utilities. Applications and instructions can be found on our webpage or at the Administrative Office in the Village Hall.

### **Water**

- Village water comes from Bolton Point Water Plant, located on East Shore Drive, operated by and for the Southern Cayuga Lake Intermunicipal Water Commission (SCLIWC).
- We are one of five municipalities that comprise the Commission. Other members are the Towns of Ithaca, Lansing and Dryden and the Village of Cayuga Heights.
- SCLIWC sets the water rate each year and each municipality charges their residents a surcharge that is used to maintain the infrastructure in their municipality.
- Remote Water Meters are used so there is no longer a need to report water readings.
- Water/Sewer Bills go out quarterly on the first of January, April, July and October. Payment is due by the 20<sup>th</sup> of that month.
- Payments are made payable to Village of Lansing Water and can be mailed to the office or left in the secure drop box in the Village Hall foyer.
